

**Bluefield State College**  
**Federal Higher Education Emergency Relief Fund-Emergency Financial Aid**  
**Summary of Grants to Students for the Quarter Ended December 31, 2021**

Bluefield State College (BSC) has received Federal HEERF I, II and ARPA funding:

1. BSC has signed and returned to the U. S. Dept. of Education the Certifications and Agreements, providing assurance that BSC will use the applicable amounts of the funds designated under the CARES, CRRSAA and ARP (a)(1) and (a)(2) programs to provide Emergency Financial Grants to Students. The amounts that BSC was authorized under these programs for emergency financial aid to students are as follows:
  - a. HEERF I → \$ 648,087
  - b. HEERF II → \$ 648,087
  - c. ARPA → \$ 2,069,791
2. BSC received and distributed \$463,525 to students enrolled as of March 27, 2020, as documented in BSC’s report dated July 3, 2020.
3. During the academic year (AY) 2020-21, BSC provided \$192,179 of emergency aid to students from HEERF I funds. The College also provided aid to students from its institutional funding in AY 2020-21. See separate June 30, 2021, institutional/HBCU report dated July 8, 2021.
4. In the first quarter of academic year 2021-22, 1,325 students were eligible to receive Emergency Relief Funds under BSC’s award parameters. BSC provided Emergency Relief Funds of \$850,875 to these 1,325 students. The amounts per student ranged from \$250 to \$1,000, depending on the students’ need and whether they were enrolled full-time or part-time as follows:

5. Additionally in the first quarter, the College distributed aid to students as follows:
  - a. Tuition discounts of \$530,599 to Pell eligible students who had academic or athletic merit.
  - b. Tuition discounts of \$42,211 to non-resident students with expected family contributions less than \$12,000, to pay the difference between their level of non-resident tuition and the next lower rate.
  - c. Tuition discounts to non-Pell eligible students who had academic or athletic merit and for non-resident students to bring their rates to the next lower rate, in the amount of \$1,013,996.

6. During the second quarter of academic year 2021-22, the College provided \$250 of emergency aid payments to 41 provisional students, totaling \$10,250, and various amounts of emergency aid payments to 164 students totaling \$130,040. The 164 students completed an application requesting funds for COVID-related issues.
7. Additionally, during the second quarter, the College awarded good neighbor, athletic or academic waivers to five students requesting assistance, for a total of \$9,914.
