- 11. BOG- No meeting next Thursday- Up coming They will have their financial report recruitment and retention report from Dr. Robinson.
- 12. College Council meeting- Learning policy will be sent to the BOG.
- 13. Nov 16 Budget meeting- 38 new students in the spring will offset deficit amounts.
- 14. 300 new students coming in would cover a deficient if that happens.
- 15. We have reserve funds that will get us through this year and next year.
- 16. Mike complimented Dr. Lambert on her retention efforts.
- 17. Dr. Picanco feels there is a real concern- 50 percent chance to survive.
- 18. Demographics of the area- population keeps decreasing-Dr Krotseng says demographics are being considered.
- 19. Dr. Picanco complimented everyone and we are all doing our part, recommending we programs that are already in place- Metro rate was huge for the college- look at

where the metro rate applies and evaluate the number of miles where students would be eligible for the metro rate and looking into areas that are currently aware of Bluefield State College. Dr. Lambert says they have expanded the Metro rate to beyond West Virginia. Concord is doing recruiting in a number of areas. Dr. Picanco to ask the President and Provost to expand the areas-Dr. Krotseng says they will look into this and get back to the committee within a week.

Dr. Lambert reported digital learning is Jeff and at this time she does not have information on who is responsible for what. Bill Bennet inquired about the security system?
