**Discuss what has been your biggest difficulty implementing the J-1 program.**

*Visiting Faculty:*

*Identifying English-speaking faculty from partner institutions in non-English speaking countries who can spend up to an entire academic year at BSC.*

*Foreign partner institutions have the same challenge faced by US institutions, namely, releasing full-time faculty to go abroad for scholarly activities and finding substitute (adjunct) faculty who will teach their courses in their absence. Reciprocal exchanges will be a rare occurrence.*

*Appropriate housing for exchange scholars along with the cost of such housing (i.e., who will cover rental costs?)*

*How can substitute (adjunct) faculty salaries be paid/justified and from what funding source?*

*Partner institutions' students: In-state tuition payment policy being considered but should be indicated as acceptable by WV HEPC.*

*Absence of financial support from WV HEPC to support salaries for exchange scholars from partner institutions or engagement in two-way student mobility with international partner institutions.*

*Third party Exchange scholars/professors (CIES/IIE Outreach Lecture Fund):*

*Dr. Jacques Bou Abdo of Lebanon, currently Fulbright Visiting Scholar at the University of Kentucky, is approved to visit BSC August 15-18, 2018 at which time he will deliver presentations on (a) Lebanon's identity, customs, culture, and traditions; (b) Cyber-security, recommender systems, privacy and mobile cloud computing; and (c) the feasibility of developing a degree program in cyber-security at BSC.*

*Anticipate grant application submission in August/September 2018 to host at least two Fulbright Scholars at BSC and area schools in October and early November and up to 4 Fulbright Scholars in spring 2019.*

*Plans underway to visit El Salvador in late November 2018.*

*Exchange Scholars: If financial support from WV HEPC is made available, BSC anticipates issuing J-1 visas to faculty from at least two partner institutions to teach at BSC for one or two semesters in 2018-19.*

*Exchange students: BSC anticipates issuing J-1 visas to partner institutions' students to enroll in the English for International Students program. They will pay tuition at the in-state rate when enrolled in this autonomous program.*
