1. Call to Order and Chair Remarks

Vice-Chair Remines called the meeting to order at 4:00 p.m., and welcomed attendees. He highlighted recent positive developments at Bluefield State University, including achievements in athletics, mining engineering, and faculty accomplishments.

2. Approval of Previous Meeting Minutes

The minutes from the previous meeting were reviewed. No changes or comments were noted. A motion to approve the minutes was made by Mr. Price and seconded by Mr. McKenzie. The motion carried unanimously.

3. President's Report – Dr. Martin

- Dr. Martin attended the State of the State address and held discussions with legislators about Bluefield State's role in academics and workforce preparation.
- Continued collaboration with the city on economic, business and living space development projects.
- Chief of Staff Josh Grubb introduced.
- The search for a Provost has concluded, with final recommendations pending.
- The search for an Athletic Director continues, with 18 applicants. On-campus interviews of the finalists will soon occur and a selection of an Athletic Director is expected to be completed this Spring.
- The Foundation is hiring a Director of Advancement to increase fundraising efforts.
- HLC Focused Visit scheduled for March 24-25; Board members encouraged to complete assessments. A report from BSU to the HLC in anticipation of this Focused Visit was submitted by Interim Provost Rhonemus.
- The College of Health Sciences has moved to its new facility, with an open house scheduled for March 26.
- A 65,000 sq. ft. facility in Princeton has been donated to Bluefield State, with plans for athletic and academic use.

Academic Update – Dr. Rhonemus

- A Notice of Intent proposal for a Bachelor of Science in Multicategorical Special Education with Autism was unanimously approved for submission to the Higher Education Policy Commission upon Motion by Bill Cole, with a Second from Chair Cole.
- Discussion on HLC Focused Visit planning and board participation.

Finance and Budget – Ms. Higgins-Atwell (Reported by Dr. Martin)

- Budget is ahead of last year's pace, with ongoing efforts to collect outstanding student balances.
- Continued adjustments may be necessary to balance the budget.

Safety and Security – EVP Benjamin

- Recent dormitory incident handled by law enforcement.
- New security company in place; feedback requested from staff.
- Officer Tony Palmer to increase campus presence and visibility.

Enrollment Update – Mr. Shidemantle

- Current enrollment is 1,242 students, a 7.16% increase from last year.
- Readmission numbers are lower than expected; strategies are in place to improve engagement.
- New targeted recruitment efforts include personalized outreach and digital marketing.
- A new admissions counselor, Andrew Vance, has joined the team.
- Open House scheduled for March 29.
